Participants who are K–12 school district employees or hold a certificate or license issued by the Michigan Department of Education (MDE) **have a PIC** in the Michigan Online Educator Certification System (MOECS) and may use the MOECS to keep track of their SCECHs. **For SCECHs to be credited to the MOECS account, the individual must complete the MDE online SCECH evaluation.** The evaluation may be accessed through your MOECS account, under the View/Update Professional Learning menu item on the left side of your screen.
